

Dear All,

I think we have a serious life threatening issue that may be 20 years in the making. That may result in my death based on the past – actions of Canada – its medical practices that are based on opinion of doctors – not medical reality.

20 years ago segues to today. 1997 – 2017.

My health journey has not started – I am still in Malaysia – Still infected – trying everything to heal myself – November 15, 2017

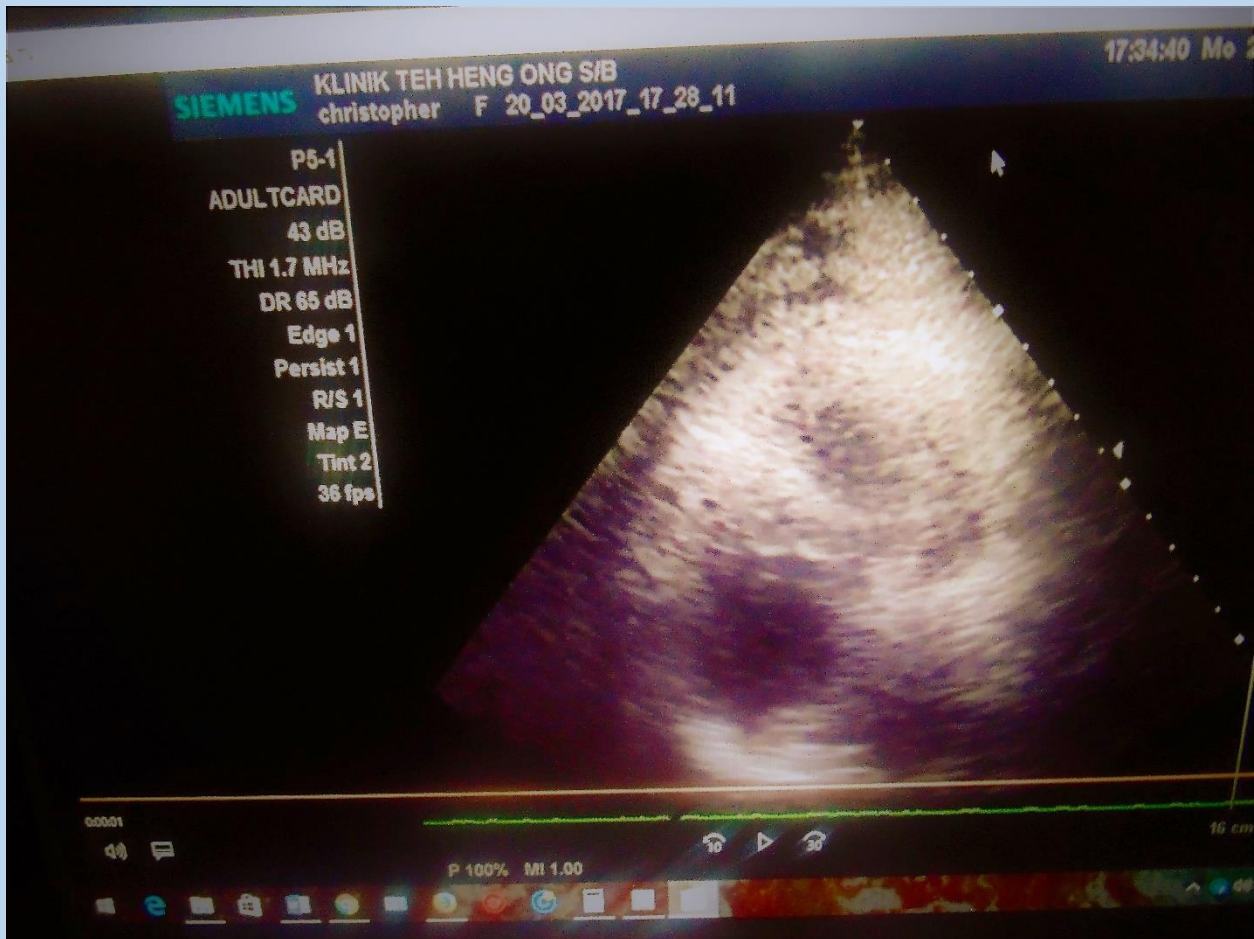
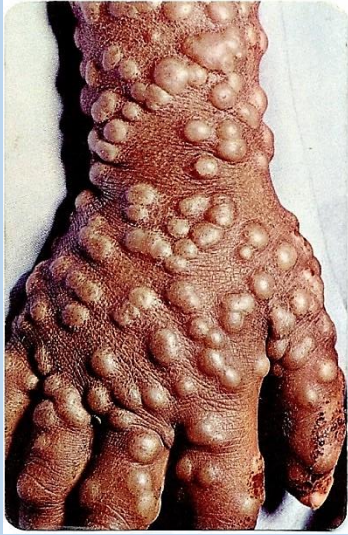
