

This document – titled – A serious offence.

**Damage to Suite C-15-05 has to be signed by Trefoil Management and the Owner of C-16-05 and C-16-06.**

- This is in 2 parts. Part A liability for damage to the apartment C-15-5. Part B liability to the damage to my body from the Assault of the construction, Dust – Concrete & Paint.

Upon my return from Thailand November 30, I discovered that the apartment was covered with Dust and small pieces of paint was everywhere and small debris. My curtains were on the floor somehow – the dust was everywhere as the door and the apartment was sealed, I could not understand why there was such a state of dirt.

As I just arrived at 5.00pm the drilling was intense and went on to 7.00pm. I went out for dinner and returned home to bed.

During the night/morning December 1<sup>st</sup>. I had a severe allergy attack and stopped breathing. I was in great pain but could not understand why I had such a severe attack. I was unaware of all the dust on my bed – and Dust – concrete and was everywhere. I was awake from 4.30 am and stayed awake until 9.30am – and took a lot of painkillers – contacted the Dr. who said get to emergency. I had to wait and until my friend who could take me.

I had some pills left over in case of emergency and none of it worked as it was a severe allergy attack. These allergies are only triggered by Dust –paint – concrete – gas – All of these I avoid and I live in the apartment to avoid any of these allergies. As the reaction is severe and sudden. And only triggered by the construction above where 2 suites C-16-05 & 06 caused the ceiling and walls to shed paint and concrete. I live in C-15 -05.

It is devastating to endure the pain and to succumb to the paralysis that occurs. Please see the video, that explains why you are liable and this is a situation that was created by Trefoil and the owners C-16-05 & 06.

I finally cleaned the place not understanding at the time why there was so much dust? Then the drilling started again and I asked AZMI what was going on. He later confirmed after I had filmed the 16<sup>th</sup> floor that it was under total renovation Please note that I had to clean the apartment thoroughly to remove the dust but now that I realise that it requires daily laundry washing and the costs have to be reimbursed. Azmi confirmed that the drilling was excessive and the noise level intolerable.

Part A- The damage to the apartment is due to falling dust, plaster and since its part of the apartment lease that I do no damage. The falling paint, plaster etc. is damage and can accelerate the detrition of the apartment. I cannot control the effects of damage done by the renovations and I require in writing declarations of responsibility of damage

to the apartment due to the construction. By Trefoil Management and the owner of the C-16-05 & 06.

I supply name \_\_\_\_\_ acknowledge that any damage done to the property C-15-05 due to the construction of C-16-05 & 06. This acknowledgment is for the rest of the tenancy April 2017. Construction damage like this – the cracks form in time the falling paint the same. I cannot be held responsible for any damage, cracks, flaking paint, chips that are due to the aggressive renovations. As Trefoil Management agreed to the terms to the renovation, they also have to sign responsibility to the damage to the Building and to the apartment. As well as to my computer equipment.

#### Part B-

Due to the serious nature of the Assault. The construction – the Dust of Paint and the concrete. I am at severe risk of anaphylactic shock. The fact that I can go unconscious due to this and that I am experiencing great pain when the attacks start and that there is no treatment due to the only fact that I am a victim due to the construction. This construction as to be modified so that I can survive. On Monday I will go up to the construction and ask that it be amended and stopped. I will have to call the Police and ask that Assault charges be placed against the owners.

I have left notes and email to Azmi who is very aware of the history I have here. C-16-06 & 05 will sign a declaration to pay all medical expenses that I will experience if I require more treatment. Plus they will pay all the cleaning that is required the bedding has to be washed every day and the place has to be cleaned thoroughly. Also as I blog and write articles the noise and dust will stop my ability to write. I am also writing a book and this Threat of a serious issue due to Construction has compromised my abilities. So the situation requires immediate solutions. I will call the Police and ask that Assault charges be laid.
