I divulged all too you- simply has it operated in the darkness of life. **People as you see - did willfully and with full knowledge of their actions choose to harm me. For reasons i cant accept - but apparently they exist. When I write all of this - its an out of body experience I am writing about myself - but I distance myself from the reality - as its so dark.**

So - I have limited time to travel - I have to move from this condo - as the death threats are too real and other innocents can get hurt Though the management has said - if Goh comes here - they will take him out., And by that I mean they may kill him as they see him as a danger to my life and the life of others - here. This is a lot of crap to deal with.

So as sick as i am - today is bad - so far - palsy has returned - all these were Toronto given experiences. And though I tried to get help in TO - there was none. Same in Malaysia. The same in Vancouver - The only place I got better in was Seoul and Osaka. There medical systems are state of the art.

If you end up advocating my care - with St.pauls you know that the Dr's are not quite prepared for such a hybrid condition. ? And what this body will do ? Plus i cant take a 15 hour plane ride which translates as 24 hours - There will be no rest leading up to the departure - no rest on the flight - very high anxiety - a bad heart that went bad - upon the infection. Based on this background, we have devised the working hypothesis that most cases of schizophrenia are caused by infections and other environmental events occurring in genetically susceptible individuals ([Torrey and Yolken, 2000](#)).

### **DISCUSSION but the patient died...**

Leptospirosis is a zoonotic disease that occurs worldwide but with a higher prevalence in tropical areas in both developed and developing countries.<sup>1</sup> It occurs both in rural and urban settings. Clinical manifestations range from asymptomatic seroconversion to acute undifferentiated fever to severe presentations with jaundice, renal failure, and pulmonary hemorrhage. To our knowledge, this is the sixth reported case of leptospirosis in patients with HIV infection and the second in the English language literature.<sup>4-7</sup> Although this patient had no AIDS-defining conditions before his first fever clinic visit, his advanced presentation at subsequent hospital admission and his rapidly progressive and ultimately fatal course make it almost certain that he had AIDS at the time of his acute episode of leptospirosis.

This case is particularly notable because previously reported patients with acute leptospirosis and HIV coinfection had severe clinical courses. Clinical manifestations differed between patients, variably including meningitis, renal

insufficiency, acute respiratory distress syndrome, and hypotension as main manifestations.<sup>4–7</sup> All patients recovered fully from leptospirosis, except one who had residual renal insufficiency. In contrast, the patient reported here experienced a clinical course of leptospirosis consistent with the more common presentation of acute self-resolving undifferentiated fever. Many believe that humoral immunity, primarily against leptospiral lipopolysaccharide (LPS), mediates recovery from acute leptospirosis and protects against reinfection.<sup>8</sup> As a T-independent antigen, leptospiral LPS would be predicted to induce antibodies in the absence of CD4+ T cell help,<sup>9</sup> explaining the high MAT titer during acute infection despite likely advanced HIV-driven immunodeficiency. The high MAT titer cannot be dismissed as HIV-related B cell polyclonal proliferation with hypergammaglobulinemia, as an etiologic diagnosis (real-time PCR) definitely demonstrated infection. The patient recovered from acute leptospirosis without antibiotic treatment, without acute complications or sequelae, and without requiring hospitalization. Acute leptospirosis was retrospectively confirmed by a molecular diagnostic technique conducted on-site in the Peruvian Amazon, which has been demonstrated to be very sensitive and specific, detecting pathogenic *Leptospira* to ~10 organisms per specimen without cross-detecting other pathogens or non-pathogenic *Leptospira*.<sup>3</sup>

We conclude that acute leptospirosis in HIV coinfection is not inevitably severe and that there is probably wide variation in clinical manifestations similar to what occurs in immuno-competent hosts. Clinical presentations and complications likely depend on a combination of virulence potential differences that vary between pathogenic *Leptospira* and host genetics of non-T-cell-dependent innate immune responses. A prospective cohort study in an HIV and leptospirosis dually endemic area would be necessary to establish definitively whether HIV infection alters the course of leptospiral infection, either acutely or in chronic infection, as it does for *Treponema pallidum*, the agent of another spirochetal disease, syphilis, which lacks the T-independent LPS antigen.<sup>10</sup>

**Dear Julie, As I have no real idea of what is going on with these people. I am here only on holiday gone berserk. I did not know who they were – as I had AKA, only Jack – it was on April 8th when they showed up at my door at another apartment in Cocobay – trying to extort \$ and again threaten me. I left and had no further contact. I literally was in hiding. Mostly due to the infection.**

**On April 8th. They, i.e. jack and his interpreter – he speaks little to no English and is always enraged - he brought an interpreter Vicky - left all their legal documents behind accidentally– all originals – that I found and recorded as they were hell bent on harassing me – stalking me and harming me. Malaysia is known for its incredible corruption. I also destroyed the originals – thinking that has he has no originals- he will stop harassing me – not sure what I was thinking – but as I discovered the illness really does a number on you. I can't see clearly some times and reading is a bit of a challenge at times – ii have had such severe fevers – blinding headaches – I told David about the bizarre colours I see in my head – when I close my eyes – I get so dizzy – the pills ? the disease? Death? I don't now.**

**I am in the wrong place at the wrong time. But these people are violent. I can't go to the Police as I had tried before – and it was blocked by Property Management claiming it was a misunderstanding.**

**The Malaysians attack you – steal from you – harass you – as you are a foreigner and it's all a misunderstanding. There is no misunderstanding that I am infected with a deadly – disease – there was no misunderstanding yesterday after weeks of seeing this man. That he would in public scream out and threaten to Kill me. ? I have only had 3**

brief ? Encounters with this man – jack. February 12th. April 8th and now May 11th. Each one escalating violence. Why?

- On all legal documents – there is nothing with my name. As I had not rented the apartment and was just a guest. So I was not responsible for anything. Except paying the rent to Yusuf and the utilities were free. But that story changed – and kept changing. And I was so infected and collapsing. I was being targeted and they kept threatening my life. If you have disputes you have ways to settle them. Instead – they kept attacking me – and trying to harm me.

- All documents are scanned copies of the originals. I now know who they were. And if it continued – even if I was murdered – they could now be found. I recorded it in my blog. As it was important to establish what was going on at Cocobay and what these people were doing.

- And that a deadly Rat disease infection was easily contracted in Port Dickson.

To have my little life destroyed by these corrupt people for absolutely no reason on my part. The disease is entering increasingly deadly phases. The neurological deterioration – the rash exploding going viral – little sleep and pain – So much drama and violence- for no reason.

A brief video – to show the topographical reality. I am not visible and until May 11th I thought I was safe. My only focus was on getting better. Beating the unbeatable.

I have many videos of the disease and record it – as it has stages – but for the life of me – I don't know how all this got so wrong?

The Canadian High Commission did not seem to know anything about this dangerous disease – or these people – or the corruption and violence.

The consulate – thought I required medical directions – though in my also lengthy letters to them – I established – I was being sent on wild goose chases – with no help – but as they are hands of - ? They can say they provided assistance – assistance that I knew about – what I required was an intervention. Protection – anything to stop the harm –

Now its much worse – the disease – is intensifying – my life is threatened – and I could die from the organ failure or be murdered. Does Canada not care when its citizens is attacked by the natives – of a country – and is now facing death from all of this.

I think great things of Canada – but why are its servants – so laissez affaire – we Canada bring in the refugees – yet I as a citizen – trying to get better – but hijacked in Malaysia. Infected – dying? And now facing – a crazy man hell bent on murdering me for what?

Anyway – I simply do not know what to do. My resources are being devoured – from the illness – I still – because I have to think – that I will live – that somehow I can survive this – the disease – but then – Jack Goh - ? Who is this man and why is he allowed to threaten – me – and stalk me. He is crazy enough to kill me. From day 1 he threatened my life – now he is hunting me. To survive I have to deny all this fear as I will be paralyzed by it. Or stroke out.

I kept trying to book flights from Thailand Bangkok – or Chiang Mai to Vancouver. But the illness took over – making me cancel my plans – over and over – the \$ I am trying to save to get back home is gone – it can be recouped if I get better. But with Jack Goh – threats .. ? I have to travel to the Town via Bus – to see the doctor – I am out of pills – but the fear of Goh – waiting in the neighborhood - ? Why is this happening? I am terrified. I would have run to the CHC – for help – but this pox – this plague – what if I am contagious..? I can't risk it – but it took months – to get this bad – but I contacted the CHC months ago.

Anyway I am updating the Pox videos – and you have the paper work. I am sending – I am not sure what intervention can take place – Can my life be saved?– Can Goh (s) be stopped from murdering me? – The illness alone is killing me – an illness that I contracted from him and his filth. Every time I write this – I collapse –
